# THE TERMS AND CONDITIONS OF PARTICIPATING IN THE PROGRAM ARE SET FORTH BELOW:

The Recipient, by accepting this contract, agrees to and accepts the following terms:

#### I. Scholarship Award

a. The Baltimore County Fire Rescue Academy has authority to award scholarships for tuition only. Books, equipment, uniforms, background checks, drug screens, test prep, or other education expenses are not an allotted expense.

#### II. Awards Allotted. The allowed number of scholarships per recipient are as follows:

- a. The scholarship will be awarded once per program and once per recipient. The Bureau Chief of the Fire-Rescue Academy may allow an exception on a case by case basis only.
- b. Seating preference is given to new applicants.

#### **III.** Obligation of the Recipient:

- a. Maintain or obtain ALS affiliation with an ALS approved volunteer company within Baltimore County.
  - i. Must remain an active member in good standing for the duration of the program and continue to serve for (3) additional years for a Baltimore County Volunteer Fire company.
- b. Maintain an overall 70% grade average for the duration of the program.
- c. Accept responsibility and place adequate study time and effort into the program. If you are having problems with the program, it is your responsibility to bring this to the attention of your instructor. Every effort will be made to give you the assistance you need, but the ultimate responsibility rests with you.
- d. Any issues with the CCBC program, must be first expressed to the instructors at CCBC prior to contacting staff at the FRA.
- e. During any activity associated with the program, you are required to be dressed appropriately, have a neat and clean appearance, and will use language and conduct consistent with a health care professional.
- f. You will represent the Baltimore County Fire Department and must remain personally responsible and accountable for any decisions you make.
