



## ***Baltimore County Fire-Rescue Academy Refresher Guide for BLS & ALS***

**Courses listed are suggestions for filling in education requirements of National Registry, only use courses you have taken or attended.**

If you are due to recertify this year, your National Registry's expiration date is March 31<sup>st</sup>. Here are a couple of things you need to know and do:

1. Log into your National Registry account
2. Make sure you are Affiliated with Baltimore County Fire Department. On your "Dashboard", scroll down until you see "Agency Affiliation". If you are not affiliated with BCoFD, please add an affiliation so you can be recertified.
3. To recertify, you will need to do a few things.

- **Nationally Registered EMTs**

- i. 20 Hours of Core Content
- ii. 10 Hours of Local Content (5 of the hours must be classroom)
- iii. 10 Hours of Individual Content
  - Take the BCoFD Online Refresher (24 hours) including skill sessions or MFRI EMT Refresher Class (24 Hours). This covers your Core Content plus 4 hours you can place into local content

- **Maryland EMTs**

- i. 4 Hours Didactic & 4 hours Psychomotor of Trauma Content
- ii. 4 Hours Didactic & 4 hours Psychomotor of Medical Content
- iii. 4 Hours Didactic & 4 hours Psychomotor of Local Content
  - Take the BCoFD Online Refresher (12 hours) including on-duty skill sessions (12 hours) or MFRI EMT Refresher Class (24 Hours). This covers your Core and Local Content

- **Nationally Registered Paramedics and Maryland CRTs**

- i. 30 Hours of Core Content
- ii. 15 Hours of Local Content (5 of the hours must be classroom)
- iii. 15 Hours of Individual Content
  - Take the BCoFD ALS Refresher (30 hours) or MFRI ALS Refresher class (30 Hours). This covers your Core Content.

5. Courses that you can use for Con-Ed for recertification.
  - a. Take a BLS CPR Class (Initial Certification: 4 Hours; Renewal: 2 hours)
  - b. Take your MIEMSS Protocol Updates (1 +/- Hours each year)
  - c. EMS Safety related classes. Officer related classes will **NOT** count.
  - d. BCoFD Courses
    - i. BCoFD HazMat Operations Refresher (1 hour)
  - e. MFRI Courses
    - i. MFRI EVOC (8 Hours)
    - ii. MFRI HazMat Awareness (8 Hours)
    - iii. MFRI HazMat Operations (20 Hours)
    - iv. MFRI HazMat Technician (20 Hours)
    - v. MFRI Traffic Incident Management – Abridged (4 Hours)
    - vi. MFRI EMT Refresher Class (12 Hours). The 24 Full EMT Refresher Class will give you 12 hours of classroom for Con-Ed.

  - g. NAEMT Courses
    - i. Advanced Medical Life Support (AMLS) – 16 Hours
    - ii. Emergency Pediatric Care (EPC) – 16 Hours

    - iv. Tactical Emergency Casualty Care (TECC) – 16 Hours
    - v. Geriatric Education for EMS (GEMS) – 8 hours
